
The Term Endowment will help the school district address hard and painful choices if emergencies or unforeseen circumstances arise (such as a global pandemic, for example!).

Reach Higher for Educational Excellence

The School District of the Chathams (SDOC) has a long history and ongoing reputation for educational excellence. Over 25 years, Chatham Education Foundation has funded over \$1.5 million in grants directly to SDOC that bring innovation to our schools to maintain and enhance this level of excellence. Chatham Education Foundation's vision is to be the leading philanthropic partner for SDOC for collaborating on innovative ideas to enrich education, support future-focused initiatives, and build a sustainable source of funding through an endowment.

In addition to annual grant funding of \$100,000, Chatham Education Foundation established an endowment to address increasing strains on SDOC's budget. Chatham Education Foundation's goal is to create a \$4M endowment to support Chatham students for years to come.

Once fully funded, a \$3M Permanent Endowment will yield approximately \$150k per year in perpetuity for curriculum-enhancing grants for generations of students. An additional \$1M Term Endowment will help to protect our school district from budget shocks and crises.





Why Private Funding

- Chatham's low per pupil spend makes SDOC extremely vulnerable to structural budget increases such as reductions in state aid and increased health insurance costs.
- State law imposes a 2% limit on property tax increases unless the public votes to approve a higher increase.
- Chatham's per pupil spend was the lowest of peer schools when the law took effect in 2010 and remains the lowest.
- In 2010 the state slashed aid to the SDOC by \$2.6M.
- Reductions in state aid and the limited ability to increase tax funding has resulted in such a lean operating budget that desired staffing levels and programming requests cannot be met without private funding.
- COVID-19 has placed further strain on the SDOC budget due to increased costs combined with likely state aid reductions looming in the near future.
- There is no room to absorb increased costs without programming cuts.



Donate to Make an Impact

Endowment pledges thus far range from \$20,000 to \$100,000.



A \$20,000 Permanent Endowment pledge is estimated to provide \$1,000 a year in perpetuity, enough to fund two \$500 teacher grants a year. About 25% of grants are in this range. Grants at this level can have a significant impact on student well-being, promoting reading and literacy and comfortable learning environment year over year.



A \$50,000 Permanent Endowment pledge is estimated to provide \$2,500 a year in perpetuity, enough to fund a \$2,500 teacher grant. About 60% of grants are in the \$0 - \$2,500 range. Grants at this level can fund needed equipment and furniture to support technology, classroom of the future furniture, the performing arts and student well-being that can be used over many years.




A \$100,000 Permanent Endowment pledge is estimated to provide \$5,000 a year in perpetuity. About 90% of grants range from \$0 - \$5,000, offering students innovative ways to engage in and out of the classroom.

Those wishing to leave a long-term legacy to support Chatham public schools now have a vehicle to accomplish this philanthropic objective, through the Chatham Education Foundation endowment.



Endowment Impact

Summit Educational Foundation (SEF) established a \$3M endowment 10 years ago, and this endowment has grown to over \$5M. SEF's annual endowment-funded grants are more than twice Chatham Education Foundation's current annual grant funding.




Establishing an endowment to meet long term needs did not impact SEF's annual fund contributions or their ability to fund immediate needs. It strengthened their position as a partner to the school district to fund strategic needs and increased overall giving.

Why Give Now

Chatham Education Foundation will match your endowment donation while matching funds last.

Double Your Gift: If you fund your endowment (through cash, shares, company match) over five years, Chatham Education Foundation will double your endowment. For example, a \$20,000 endowment would be matched 100% for a total endowment of \$40,000. This endowment would contribute ~\$2,000 annually in perpetuity for grant funding.

Triple Your Gift: If you fund your endowment with no restrictions over two years, your endowment will be tripled. For example, a \$20,000 funded endowment funded over two years would be matched 200% for a total endowment of \$60,000. This endowment would contribute ~\$3,000 annually in perpetuity for grant funding.



Stewardship¹



Our Endowment Portfolio is managed by Chatham Education Foundation's Finance Committee. Funds are invested in low-cost Vanguard mutual funds. Gifts in the Endowment are held by Chatham Education Foundation in perpetuity. The initial gift is invested, and a portion of the average annual investment return is spent for the purpose designated by the donor. The remaining income is added to the principal as protection against inflation. Thus, a Endowment gift today will retain its relative value for future generations.

A rigorous grant review process ensures that donor funds are spent wisely:

- Grant proposals are developed by SDOC teachers and administrators, then reviewed and approved by Chatham Education Foundation's Board of Trustees and the SDOC Board of Education.
- SDOC periodically reviews individual grant accounts and returns unused grant funds to Chatham Education Foundation.
- All grant recipients are required to submit a final grant report, which includes the
 expenditure of funds and a description of grant project outcomes.
- SDOC and Chatham Education Foundation accounts are audited annually by independent auditors.

2020-2021 Grant Award Highlights

Outdoor Classroom at MAS

CEF funded a \$16,000 grant and partnered with the MAS PTO to take learning outdoors. The space promotes whole class instruction with enough safe seating for each student.

Technology for Student Engagement

The \$12,300 grant includes three online instructional resources: Ed Puzzle, Screencastify and Padlet for use by all schools and students to foster interactive learning. The programs give teachers the technology to build lessons and engage with students, whether in-person or virtually.

Clear Communication with Masks

The \$3,300 grant award provides teachers in music, ESL, World Language and counselors across the district with 200 reusable masks with clear fronts. Students can see their teachers' lips and facial expressions, enhancing learning and social-emotional wellness.

CMS Community Social Justice Read

The \$19,266 grant calls for a multi-faceted approach to the reading of the book Ghost Boys by Jewell Parker Rhodes by CMS students, parents, and school staff. In addition to the 1,200 copies of Ghost Boys, 240 copies of non-fiction books and a series of Professional Development workshops for teachers will help students engage in authentic conversations about their world.

Ready Readers, SBS, MAS, WAS

The \$7,447 grant will benefit students at all three of our K-3 schools. This grant provides many copies of 130 new titles for reading levels A-K. Included with the system are "take home" books and transport bags. Additional teaching tools will support individualized instruction, both virtually and in person.
