For over twenty-five years, Chatham Education Foundation (CEF) has partnered with the School District of the Chathams to support educational excellence through parent and community donations. This year, grants have transformed math classrooms at CMS and CHS, provided tools for beginning readers, optimized self-contained special education classrooms, and funded a district-wide choral festival for 400+ students that combined music with social-emotional learning.
