



Dear Friends and Neighbors,

Since its inception, the Chatham Education Foundation has granted nearly \$1.3 million to the School District of the Chathams ("School District") to support projects and initiatives that would not otherwise be funded.

Chatham Education Foundation partners with the School District to collaborate on innovative ideas, support future-focused initiatives, and establish a sustainable source of funding. When teachers and administrators see an opportunity to enrich and inspire students in their classroom or school that the School District's limited budget cannot cover, they can request a grant from Chatham Education Foundation. Grant funding impacts every student, covering all six Chatham public schools, all grade levels and subject areas.

The need for grant funding remains strong as budgets are expected to cover more with less every year.

- The number of students in the School District has increased by over 25% in the last 13 years. Unfortunately, the School District's budget has not kept pace with the rise in student enrollment.
- When a home is renovated or rebuilt and property taxes on that home increase, NONE of that additional revenue is added to the School District budget.
- The per-student tax levy in the School District is below peer schools and below the New Jersey and Morris County average. Private funding through Chatham Education Foundation is critical to help address this difference.


